With reference to the above, you are requested to please quote your lowest rate for providing diesel AC Sedan car along with driver on hired (per day) basis for Protection, Automation & Communication Circle, MSETCL, Nashik on or before 25.07.2022 up to 15:00 Hrs. in Schedule "A" (Enclosed herewith) on the terms & conditions given below.

Terms & conditions:

- 1. Your offer should reach this office on or before date 25.07.2022 up to 15:00 Hrs.
- The offer is to be submitted in two separate sealed envelopes as below
 Envelop No.1: Contain the associated valid vehicle documents/certificate/proof of qualifying pre-requisite, as below
 - 1) Vehicle fitness certificate.
 - 2) Insurance of the vehicle for current year
 - 3) RC/TC book with tax paid details
 - 4) PUC Certificate for the current year
 - 5) Contract Carriage permit (Tourist Permit)
 - 6) Driving License of driver
 - 7) PAN Card of vehicle owner
 - 8) Vehicle mileage i.e. Km/liter with AC (it should be 18 Km/Lit minimum)

Envelop No.2: Should contain rate of providing diesel AC Sedan car along with driver on hired (Per day) basis as per "SCHEDULE A".

The above two envelop is to be insert in one main envelop duly super scribed with the following details-

Envelop No.2, i.e. the price bid will be opened only after verifying all documents/certificates in envelop No.1 and confirming that the same are submitted as per pre-qualifying requisites.

- Rates quoted should be valid for 12 months from placement of order.
- The Working hours will be normally from 09:30 to 20:00 hrs. On working days. However, in case of emergency, it will be required beyond 20:00 hrs. or before 9:30 hrs. & on holiday also.
- 5. The registration of vehicle should not be more than 7 years from the date of publishing of this enquiry.
- 6. The mileage of the vehicle should not be less than 18 km/ liter.
- The responsibility of comprehensive insurance, PUC, taxi permit & RTO formalities will be with vehicle provider.
- 8. Agency should have experience of providing vehicle in MSETCL.
- In case of non-availability of vehicle on account of any reason, alternate vehicle should be provided by agency having complete valid vehicle documents.
- 10. Driver should have valid driving license.
- 11. While on MSETCL's duty, the vehicle driver must be in the uniform as per RTO guidelines.
- 12. The driver should be polite in behavior and should not be drunker / smoker.
- Only diesel will be provided by MSETCL. Parking & Toll charges will be reimbursed by MSETCL.
- 14. Overtime will not be provided if vehicle is used beyond working hours.
- 15. Halting charges will not be provided if vehicle stays out of headquarter while on official duty.
- 16. Vehicle will be used in Nashik, Ahmednagar, Dhule, Nandurbar Jalgaon, Mumbai or beyond this jurisdiction as and when required.
- 17. Payment will be effected on per month basis within reasonable period as per availability of funds.
- 18. Income tax & service tax as per rules will be deducted from bill as per the prevailing rates.
- 19. Security deposit of 5% of order value should be deposited in MSETCL during the execution of work order.
- The owner will be responsible for all risks that may arise during hiring period of vehicle operation.
