

- 1) **Name of work:** Providing diesel vehicle (Swift/Indigo equivalent or above) with driver on hire basis for Six months from date of actual engagement of vehicle OR till the receipt of new departmental vehicle whichever is earlier for the Superintending Engineer, EHV O&M Circle, Karad.
- 2) **Valid Quotation:** At the time of submitting the quotations, the vehicle shouldn't have been engaged at any other place.
- 3) The vehicle must be with valid RTO tourist permit. The vehicle model within 05 years will be preferred.
- 4) Only Diesel will be supplied and Toll charges will be paid by the MSETCL.
- 5) The vehicle will be utilized on any day throughout the contract period as per the requirement of undersigned.
- 6) You will have to pay the security deposit of 5% of the order value within Seven days from the date of receipt of firm order.
- 7) The quotations should reach to this office on or before **25.07.2022 up to 16:00 Hrs.**
- 8) Payment will be made per month basis after satisfactory completion of work subject to availability of funds.
- 9) The right to reject any or all quotations is reserved by the undersigned.

- 1) Period of contract: **Six months from the date of actual engagement of vehicle OR till the receipt of new departmental vehicle from C.O., Mumbai whichever is earlier.**

- 3) Only Diesel will be supplied and Toll charges will be paid by the MSETCL.
- 4) The normal duty hours will be from 9.00 to 19.00 Hrs; on every working day. However per day rate will be treated for 10 Hrs; and extra hours will be considered as O.T Rs/- per hour; however, either O.T or halting charges whichever is less will be paid on a particular day.
