### **2. TECHNICAL QUALIFYING CRITERIA:**

**I.** If the bidder is the OEM i.e. Manufacturer, then he should be having valid Factory License – Proof thereof. OR If the bidder is authorized dealer of the manufacturer, he shall have to submit the documentary evidence such as **authorization letter or certificate of authorization from the original manufacturer**. The certificate/undertaking from cell manufacturer shall be submitted that after sales service support shall be provided by manufacturer through you.

The bidder i.e. either manufacturer or authorized dealer should possess experience of supply of 33kV & above capacitor bank cells during last 09 years in MSETCL or other State transmission Utility for amount of work orders values either following;

- a. Single completed orders for any of the above works for amount of at least 70% amount of the estimated cost, **OR**
- b. Two completed orders for any of the above works each having amount of at least 40% amount of the estimated cost, **OR**
- c. Three completed orders any of the above works each having amount of at least 30% amount of the estimated cost.

**Note: The amount of successfully completed works under the work order in force will also be considered.**
