1. **Scope of work:** As per schedule "A".
2. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR Supply of water through private connection from neighboring farmers for 400 kV R S Kumbhargaoon, Nanded under 400 kV R S Division Kumbhargaoon, Nanded. The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule "A" format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. (Enquiry No. ____ be quoted).
3. **Quoted Rate:** The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule "A". Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
4. **Important Dates:** Quotations invited from **24.08.2022 from 10:00 Hrs**, so as to reach this office up to **30.08.2022 up to 17:00 hrs** and the same will be Opened on the same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
5. **Taxes:** Taxes will be paid & recovered, as per rules.
6. **Order Value:** The order value is restricted to the amount of **Rs.2,33,640.0 only** (Incl. of GST).
7. **Period of Contract:** The period Contract will normally be 365 days from the date of issue of order or till order amount exhausts or local water arrangement made by MSETCL, then the services will be discontinued by giving 15 days' notice period.
8. **Payment:-** The payment will be made on monthly 'RA' bill basis. Payment will be made after submission of that bill, the payment against this contract will be effected by MSETCL within reasonable time as per funds availability.

14. You will have to arrange 75mm water pipeline up to compound wall of 400kV R S Kumbhargaoon, Nanded from your Borewell connection and any maintenance on water pipe line up to boundary wall.
15. You will have to be done any breakage or leakage or any kind of maintenance issue of water pipeline from your bore well to compound of substation at your cost.
