1. <u>**DUE DATE**</u>: The techno commercial bids complete in all respects should be submitted on or before above mentioned dates positively.

- 2. Rates quoted should be on firm quotation basis and No extra charges for transportation, T&P, skilled workmen etc. will be given and same will be arranged by you.
- 3. **SCOPE OF WORKS**: work of Providing & Fixing of 48 Watt energy saving LED Street lights at 400kV RS Dn. Khadka-Bhusawal.
- 4. **QUOTED RATES**:-You are requested to quote your unit rates for the items mentioned in the schedule. (Please quote ex-works price in ex-works field & applicable GST in GST field).
- 5. <u>PAYMENT</u>: Payment will be effected after completion of work, SAP Activities, as per actualwork done and as per availability of funds.
- 6. **RATES & TAXES:** The Rates quoted should be valid at least for 120 Days and should be including of all Labour charges & incidental charges including labour cess but excluding GST as per applicable rate & relevant act. Please quote your GST registration No. on quotation.
- 7. **WORK ORDER VALIDITY**: The work order is valid up to the exhaust of work order amount.
- 8. The income tax & other taxes will be deducted from your bill as per prevailing rules.

- 9. COMPREHENSIVE INSURANCE: You have to submit the comprehensive insurance of United India Insurance Company Limited Policy of 60:40 ratio for work order amount as may be necessary to protect your (contractor) interests & the interest of The MSETCL, against all risk valid up to the work order completion period. It is responsibility of the contractor to takeout all necessary insurance of material/equipment/labour for execution of work for his liabilities direct/indirect and same must be attached with the invoice otherwise 1% on work order value will be deducted from bill.
- 10. **INCOME TAX**: Income tax. GST TDS will be deducted as per Govt. Rules.
- 11. **SECURITY DEPOSIT:** 5% of the order value as security deposit will have to be paid by you within 7 days from the date of issue of LOI order in the form DD/FDR/BG/Cash of any Nationalized / scheduled Bank in the name of the Executive Engineer 400KV RS (O&M) Division Babhaleshwar to this office valid for three years. The same will be refunded only after satisfactory completion of guarantee period.
- 12. In any loss occurs to MSETCL's property during execution of work, the same will be recovered as per prevailing rates from your bill.
- 13. **AGREEMENT:** The contractor has to execute the bond agreement as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with Rs.500/- stamp duty before starting of the work.
- 14. MSETCL will not be responsible for any accident or damages to your staff during execution of work. All safety precautions are need to be taken while working in switchyard and it is are sponsibility of agency.
- 15. All other standard conditions of contract prevailing in MSETCL are applicable in this casealso.
- 16. <u>TOOLS & PLANTS</u>: -All tools & machinery required will have to be arranged by you at your cost. If the tools & plants are provided by MSETCL on rent basis, the standard rent as per MSETCLrules shall be recovered from your bills.
- 17. **TERMINATION OF CONTRACT:** The undersigned reserves the right to cancel the contract agreement, after giving due notice to the contractor, in the event of the breach of contract in any respect or undue delay in execution of work / starting of the work etc.
- 18. **PERIOD OF CONTRACT:** The period of completion of entire work of SRM E-Enquiry is 90 days from the site handed over. However the work is to be completed within stipulated time periods per the instructions of Executive Engineer of concerned Division/Office. In no case the programmed laid down should be delayed.
- 19. **SUPERVISION OF THE WORKS:** The works shall be under the overall supervision of Operating officer i.e. **Executive Engineer of concerned division or his representative.** The Bidder shall obtain a certificate from the concerned Engineer incharge for having Successful execution& completion of the works satisfactorily. The locations where it is necessary to carry out the above said work will be informed by the operating officer &on priority basis where the work is necessary to be carried out.
- 20.<u>INSPECTION</u>: The Executive Engineer of concerned Division/Officer his representative will inspect the material required for carrying out the above said work as per MSETCL standard specification. If any discrepancy observed, the same will be rejected & intimated to the Executive Engineer 400 kV RS Dn, Khadka-Bhusawal.

21.GUARANTEE PERIOD:

- a. The bidder shall warranty / guarantee that, the equipments/material supplied by him will be new and in accordance with contract documents & will be free from defects in material and workmanship for a period of 24 months from the date of final acceptance of works by MSETCL. Any defects developed due to defective materials and / or workmanship during testing and commissioning of equipments or during the guarantee period of 24 months from the date of final acceptance of work by MSETCL, shall be rectified or made good by the bidder at his own cost.
- b. The bidder's liability shall be limited to repair / replacement of any defective part in the equipment of his own manufacturer or those of his sub-bidder and arising from faulty design, materials and / or workmanship. All cost for the repair and / or replacement of defective part such as dismantling, re-erection, supply, transportation etc. shall be to the account of bidder.

- 22. **QUALITY OF WORK & MATERIAL**:Bidder will be responsible for quality of work & workmanship. The material used to be strictly as per specification.
- 23. **GENERAL:** MSETCL general Terms and Conditions for works are applicable to this contract.
- 24. The undersigned reserves the rights to accept or reject any or all the Quotations without assigningany reason thereof.
- 25. The disputes, if any, shall be subject to the jurisdiction of the Bhusawal Court only.
- **26.** The undersigned reserves the right to cancel the SRM E-Enquiry at any stage or cancel any or all quotations without assigning any reason thereof.
- 27. SUBMISSION OF BILL & PAYMENT:- You will have to submit the original R. A. bill wise Tax invoice in triplicate including work order No., Pan No., GST No. to this office in the name of undersigned to this office. The same will be submitted to the concerned unit for further process. After that the concern Incharge will verify & certify the bill as per MSETCL standard procedure & submit the same to this office for effecting payment. After due audit & verification, Executive Engineer, 400 kV RS Khadka-Bhusawal, shall make necessary arrangement for effecting of the payment as per the availability of funds at 400 kV RS Khadka-BSL. However, the payment will be made as per actual measurement & as per the actual work done.

a) BILL SHALL BE CONTAINED:-

- 1) GST Tax Invoice
- 2) E-way Bill/Lorry/Railway receipt in case of material transported if any
- 3) Guarantee/Warrantee certificate.
- 4) Detailed work completion report
- 5) Certificate of supervising officer for approved material.
- 28. Following are the list of qualifying documents required please attached for qualifying in the Techno-Commercial Bids for opening of the price Bids. (If yes please attach the following documents)
 - a) Bidder should be register under GST Act Proof thereof.
 - b) Valid Firm Registration under Bombay Shop Act and Establishment Act/ Latest Gram Panchayat NOC or Registration as Industry as applicable.
 - c) PAN Card.
 - d) Income Tax returns filed for last 03 financial years.
 - e) Work order copy along with work completion certificate of similar type of works as a proof of Experience of any Govt. / Semi-Govt. / Private sector utilities.

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office.

- 24.ACCIDENT The safety precaution and procedures shall be followed scrupulously at site. If any fatal or non fatal accidents occur during the course of work to your labours, the MSETCL will not be responsible. The compensation if required to be paid will be at your cost and risk only. You will be responsible for the safety of your labours/employees and also safety of MSETCL equipments/material if any MSETCL equipment/material is damaged; you will have to make the loss good at your risk and cost otherwise same will be recovered from your bill.
- **25) DAMAGE TO PERSONS AND PROPERTY: -** You will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill.

26) SUBLETTING OF THE CONTRACT:-

a. The contract/work order of any part there of shall not be assign/transfer or sublet without prior written permission of undersigned. Even if competent authority such permission is granted it shall be responsibility of principal contractor to whom the work order was originally issued to compete the work as per terms of contract/work order.

- 27) <u>RISK AND COST:-</u>If you fail to carry out the work in full OR in part, the work will be got carried out from other party even at higher rates and the difference in rate will be recovered from your risk and cost. It will be treated as breach of contract & contract will be terminated and order will be cancelled by forfeiting the security deposit.
- **28**) **SATISFACTORY PERFORMANCE:** If you fail to execute the work satisfactory as per time schedule, it will be treated as breach of contract & contract will be terminated and order will be cancelled be forfeiting Security Deposit.
- **29)** T.D.S., GST, LABOUR CESS & APPLICABLE TAXES:- The T.D.S. at source as per prevailing rates & rules or at the rate amended from time to time in accordance with the provision of financial act, GST as per Govt. Rules of taxes as applicable, Labour Cess @1% under the Building & other construction workers welfare cess act 1996 & Applicable taxes if any will be deducted from your bill.

You shall obey the labour laws Electricity act. Electricity rules & workmen compensation act & responsibility for any compensation due to accident lie with you.

- **30)** APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT: The Works / Materials should be carrying out as per the standard practices of MSETCL & the terms & conditions stipulated in the RFx/SRM E-enquiry will also a part of the contract & will be binding on you wherever it is not specifically mentioned. MSETCL reserve the right to add more terms & conditions during the contract period if found necessary. Notwithstanding anything stated here, the Board's General Terms & conditions of contract shall also be applicable to this contract.
- 31. <u>TERMINATIONS OF CONTRACT</u>: The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of the breach of contract in any respect or undue delay in execution of works /starting of the works.
- 31) <u>SUSPENSION / HOLDING OF WORK:-</u> If the work has to be suspended due to any reason i.e. stay order from court of law, legal held up from any other Agency, shut down etc. the MSETCL shall not pay any compensation / damage to the contractor towards item like idle labour, etc. In such cases the contractor is not liable for claiming extra payment.
- **32) JURISDICTION:** All disputes or difference arising under, out of or in connection with this order, so concluded shall be subject to the exclusive jurisdiction of Bhusawal Court. In case any damage occurs during the work, the cost of such damage will be claimed with Govt. Insurance fund, Mumbai; however if our claim is rejected then you will have to make the loss good at your cost. All the MSETCL rules and regulation provisions of Indian Electricity Acts and rules; other Govt. rules as may be applicable from time to time will be applicable to this order and the same will be binding on you.
- **33**) **FIRST AID BOX:** You will have to keep & maintain the first aid box & safety measures at site for the labors.
- **34)** The right to add/alter/modify/ order partly or fully at any stage or to cancel without assigning any reason thereof is reserved by the undersigned.
