TERMS AND CONDITIONS:

1. The EMD and Tender fees is to be paid online on the account of MSETCL through website <https://srmetender.mahatransco.in>. **Due Date:- 17.10.2022 upto 10:00 hrs.**
2. Document should upload following digitally signed scan copies of documents/certificates online under:-

Technical Bid.

- Submit the performance /Experience certificate for similar nature of work at any HVDC station in India.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the work order mentioned in the experience certificate.

Commercial Bid.

- PAN Card & GST Registration.
- P.F. Registration.
- Income Tax return for last three years
- Valid Electrical Contractor License and Shop Act License.
- Valid Workman Compensation Policy. Valid insurance policy from M/s. United India Insurance Co. Ltd., on co insurance cum servicing basis in the ratio of 40:60 (i.e. the Govt. Insurance fund @40% and the United India Insurance Co. Ltd., @60% which will be valid for 2 years from the date 01.12.2013) entrusted by Director of Insurance , Govt. of Maharashtra. **The INSURANCE will be required at the time of execution before issue the purchase order.**
- Annual Turnover for last 3 years duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last 3 years duly certified by Chartered Accountant should not be less than 20% of estimated cost.

- Solvency Certificate for the Current Year last 06 month equivalent to an amount not less than 25% of the estimate cost of work. It should be drawn on schedule/nationalized Bank.
- List of skilled personnel's along with qualifications.
- List of T&Ps available with the agency for execution of work.

3. Scope of Work:

- Servicing of isolators.
 - Trials of isolator and earth switches for removal of mechanical and electrical troubles, if any.
 - Alignment of isolators and earth switches for removal of mechanical troubles, if any,
 - Troubleshooting of electrical troubles, replacement of faulty electrical components, if any,
 - Cleaning of jaws of isolator and earth switches.
 - Checking indications of open and close at the SCADA.
4. The Contractor rates should be in percentage (%) based on estimate cost.
 5. Rates should be valid for 120 days after commercial opening of the enquiry.
 6. Rfx fee is Rs.118/- including taxes (Is non refundable).
 7. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
 8. Income Tax will be deducted from contractor's bill, as per Govt. Rules
 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
 10. Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company in the approved proforma on stamp paper of Rs. 500/- (Five Hundred Only) at your cost as per the D.O. ltr no. Mudrank-2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. and Co.'s Adm. Circular no. 207 dtd 17.04.10.. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, for the work executed under the contract.
 11. Before issue of work order, the contractor will have to pay security deposit of @ 5% of the order value on any scheduled, private or nationalized bank **either by-**
 - i) F.D.R. or D.D.** drawn in favor of MSETCL, Padgha **or by RTGS**
 - ii) B.G.** drawn in favor of MSETCL, Padgha.

Same will be refunded after expiry of order period. No interest will be paid on this deposit.
