Zone III with ESIC as per the Schedule 'A'. The work should be purely as per the instructions of the Executive Engineer. The bidder should carry the survey and understand the scope of work before bidding.
- 2] ✓ The prescribed form i.e Schedule 'A' duly filled in with the rates written in words and figures and signed should be sent by Registered post or in person to The Executive Engineer EHV O&M Division, Dombivali.

- 6] ✓ Payment : Payment will be made by the EHV O&M Dn Dombivali within reasonable time after completion of the work satisfactory in each month and on receipt of your bill in triplicate and certificate obtaining from the Engineer incharge for the work executed.
- 7] ✓ In case of any dispute regarding any clause of the work order or works, the decision of the undersigned will be final and binding on you.
- 8] ✓ You should not affect the transfer of work or any part of it to any other agency.
- 9] ✓ You will be cover under standard terms and condition contained in MSETCL tender and contract for the works.
- 10] ✓ Jurisdiction : The jurisdiction of all legal proceedings / suits as regards to the works under contract will be under Thane District Court.
- 11] ✓ Tax deduction at source: In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. 
