TERMS AND CONDITIONS:

- The quotations should reach to this office on or before 14.11.2022 upto 16.00 Hrs.
 This office shall not accept any responsibility for late receipt of quotations due to postal delay.
- 2) The contractor should submit copy of valid electrical contractor license & has to furnish GST, PAN No. in the offer.
- 3) The bidder should have an experience in execution of similar work.
- 4) The rates quoted by the bidder, shall be considered as inclusive of GST & all other duties, taxes other levies LW Cess, IT etc. which are payable by the contractor as per statutory regulations.
- 5) Estimated amount of work is Rs.1,96,961.64/-(Incl.GST).
- 6) The bidder shall quote his rate in column no.5 mentioned in schedule 'A'.
- 7) Income tax shall be deducted from the bills at prevailing rates.
- 8) The offer shall remain valid for 60 days after the due date.
- 9) **Security Deposit:** Within Fifteen (15) days of the receipt of notification of award i.e. the letter of intent from the Employer, the successful bidder shall furnish the security deposit amounting to 5% of the contract value by cash/ cheque/DD.
- 10) The Security deposit shall be returned after settlement of final bill & NOC from the SDO.
- 11) **Period:** The time period for completion of the item under Schedule 'A' under this contract will **be One Month**. The period shall be entitled from date of intimation from MSETCL.

- If the work is not completed within stipulated period, the liquidated damages shall be levied at 1/2% (half percent) of the total contract price per week of delay subject to maximum of 10% (Ten percent) of the contract price for the entire scope of work.
- Payment will be made at Division Office, Kolhapur after completion of 100% work carried out by the contractor for all approved works executed as fixed by the Engineer after scrutiny of bills at concerned Sub-Division Office.
- The contractor has to execute the agreement on stamp paper as per Govt. rule, before 14) commencement of work.
- Addl.Exe.Engineer,EHV Sunstation Projects Sdn,Kolhapur will act as operating officer 15) for this contract & instructions should be obtained from him as & when necessary for execution of work.
- All T & P, Labour, Crane etc. shall be arranged by the contractor at his own cost. 16)
- The contractor shall make his own arrangements for the engagement of all labour local 17) or otherwise and shall make his own arrangement for their accommodation & transportation. Permission will not be granted to stay at site.
- The contractor shall not sub-let the works awarded on him under this contract. 18)
- The bidder shall arrange for posting his own security personnel at his own cost to 19) safeguard the material handed over to him not only at his storage yard but also at the work site till such time the complete job is ultimately handed over to Maharashtra State Electricity Transmission Company Ltd.
