- 1] Scope of work: Work of new LT cable laying & earthing work & change of burnt board re-wiring at power supply at EHV Project Circle, Kalwa as per attached schedule.
- 2] Security deposit: The successful contractor will have to pay Security deposit amount 5% of the total value of order i.e. **Rs. 18,950.00/-** by cash or by demand draft to this office valid for 6 months.
- 3] Contractor shall furnish EMD amount is Rs. 500/- in the form of Cheque or DD in the name of "MSETCL Mumbai" or by cash along with the quotation and write M. R. No. along with vendor no. over the sealed cover of quotation.
