



## INSTRUCTIONS FOR PRINTING OF ADVERTISEMENT

- 1) Unless specifically asked for the advertisement need not occupy more than 3 column maximum space. M.S.E.T.C.L. Emblem should be printed on upper left corner of the advertisement.
- 2) Spacing/ leading while printing the text matter of the advertisement should be kept minimum.
- 3) Name of the officers & the office address of the authority who has issued the advertisement, should not be given at the top or bottom since same is incorporated. Only designation of the officer should appear at the bottom.
- 4) The words "M.S. ELECTRICITY TRANSMISSION Co. LTD." should not be repeated at the top or bottom as the same are already incorporated in the matter. Similarly, telegraphic address, telephones, date on which advertisements are issued etc. should not be given in the advertisement unless there is specific instruction to do so.
