4. The rates should be quoted on firm quotation basis. The rates should be inclusive of drivers salary, fuel cost. Taxes should be quoted separately.

5. The normal duty hours will be from 09.00 to 19.00 hrs. on every working day & you will have to make vehicle available at **Chinchwad sub division** as per the instructions of Addnl. Executive Engineer, Line Maintenance S/Dn-II, Pune. The running of hired vehicle will be the area of operation under Line Maintenance S/Dn-II, Pune.

6. Driver: Vehicle will be driven by your driver who shall be well behaved, neatly dressed with good habits. He should scrupulously (carefully) follow all rules & regulation of RTO & traffic police. He must possess valid driving license.

7. The contract amount will be limited to **Rs. 5,50,000/-** (**Inclusive of GST**) including drivers salary & fuel charges and period will 11 months or exhaust of order amount whichever is earlier. You have to pay 5% of work order value as SD.

8. The vehicle should be registered on or later 2019 (submit document proof) preference shall be given to such vehicle.
