**5.** The normal duty hours will be from 09.00 to 19.00 hrs. on every working day & you will have to make vehicle available at **Chinchwad sub division** as per the instructions of Addnl. Executive Engineer, Line Maintenance S/Dn-II, Pune. The running of hired vehicle will be the area of operation under Line Maintenance S/Dn-II, Pune.

**6. Driver:** Vehicle will be driven by your driver who shall be well behaved, neatly dressed with good habits. He should scrupulously (carefully) follow all rules & regulation of RTO & traffic police. He must possess valid driving license.

**7.** The contract amount will be limited to **Rs. 5,50,000/- (Inclusive of GST)** including drivers salary & fuel charges and period will 11 months or exhaust of order amount whichever is earlier. You have to pay 5% of work order value as SD.
