1.From 10:00 AM to 11:30 AM – Attendance and enrollment of U.Es. for attending Lucky Draw by submission of their updated passbook duly certified by Executive Engineer (Civil) of concern Department in Pune District. Please note that the U.Es. arriving late after 11:30 AM will not be considered eligible in any case for attending Lucky draw scheme.

- 2. From 11:30 AM to 12:30 PM Scrutiny of documents such as validity of Registration of U.Es., status and verification of passbook, verification of attendance of present U.Es.
- 3. From 1:00 PM to 1:30 PM Lucky Draw program.

The lottery/Lucky draw procedure will be carried out in the following manner:-

- a) If the no. of U.Es. present for lottery are more than the works to be allotted under Lottery scheme then closed ballet paper mentioning name of work + blank ballet paper both equal to no. of present U.Es. will be prepared and kept in box for execution of Lucky draw.
- b) During execution of Lucky draw, the present U.Es. to whom the work has not been allotted till the date of lottery notice will be given first preference for collection of ballet papers.
- c) After that, the present U.Es. to whom only one work has been allotted till the date will be given second preference.

Note: As per MSETCL registration certificate clause no.04, MSETCL BR No.112/10 Dt.17.11.2016 annexure-1 and GR Sankirn/2015/prk/3/Urja-5 Dt. 26.03.2015 clause no.01. annexure-1, Updated PASSBOOK with work done entries duly certified by HOD of concern department for works executed at any Government / Semi Government or Private organization under the Unemployed Engineer scheme is MANDATORY for ATTENDENCE which may please be noted.
