3.0 QUALIFYING REQUIREMENT

Compulsory Primary Documents:

- i) Valid Certificate of Registration of appropriate class from PWD/MES/Railways/Jeevan Pradhikaran. etc. OR from Any Govt./Semi Govt. & Central Government. Undertaking regarding exemption availed by the agency having registration value more than 1.5 crores in case of PWD (as per Annexure-I).
- ii) GST Registration certificate having active status.
- iii) Statement of Net worth during the last year ending 31st March of previous financial year for an amount equal to 25% of the cost put to tender duly certified by Chartered Accountant. Net Worth = Equity share capital + Reserves - Revaluation reserves - Intangible assets -Miscellaneous expenditure to the extent not written off and carry forward losses. The bidder should submit statement of Net worth duly certified by the Chartered Accountant. (with UDIN number)
 - iv) Average Financial Turn-over during the last three years ending 31st March of previous financial year should be at least 30% of the cost put to tender. The agency has to submit Annual Turnover Report of last 3 years duly certified by Chartered Accountant/Registered Income Tax Practitioner. (with UDIN number)
 - v) Agency has to submit the Certificate of Experience for execution of Civil works in Govt. organization as well as private sector duly signed by the officer not below the rank of Executive Engineer or equivalent in case of Govt. works or from Competent Authority of private sector. In case of private sector, experience certificate along with copies of agreement of work and work orders mentioned in the certificate are essentially required.

Experience of having successfully completed civil works during the last 7 years ending the last day of month previous to one in which the tenders are invited should be either of following. a) " Three completed similar works costing not less than the amount equal to 40% of the cost put to tender.

b) "Two completed similar works costing not less than the amount equal to 50% of the cost put

c) "One completed similar work costing not less than the amount equal to 80% of the cost put to

Definition of similar works:- a) Civil works which should include execution of asphalting/ bituminous items for road, pavement etc.

- b) In case of civil works which involves composite works and where it is not clear from title of work that the nature of work is exclusively of asphalting/ bituminous item in such cases some items of asphalting/ bitumen items should have been executed for road, pavement etc. and the details viz. work order to be attached in such case.
- vi) E.P.F. Registration Certificate.
- vii) Income Tax return for last three financial years.
- viii) PAN card.
- ix) Payment of EMD

4.0 General Points:-

- 4.1 The prices to be quoted against this IFB shall be in Indian Rupees only.
- 4.2 A complete set of documents can be downloaded by the bidder from MSETCL's SRM –e Tendering website. The cost of bidding documents should be paid online at the time of bid submission.
- 4.3 The bidder shall be required to pay Earnest Money Deposit (EMD) online equivalent to 1% (one percent) of the cost put to tender.
- 4.4 The tender is invited on percentage basis. For Evaluation of the Tender, the total price including all taxes & duties shall be considered. The LOA will be placed on the final accepted price including all applicable Taxes & duties.
- 4.5 Variation in Statutory Taxes / Duties (if any)/ royalty of material will not be payable.

- 4.8 The new bidders are requested to complete the contractor registrations for SRM etendering with MSETCL as per the procedure prior to the date of submission of the tender documents.
- 4.9 The Authority inviting the tender may call the participant of srm e-tendering who has submitted on line technical & commercial bid and paid the requisite EMD upto due date, for submission of soft copies through srm e-tendering Evaluation and deviation of prequalifying documents, in case of (a) Non-uploading of pre-qualifying documents, if any, (b) Corrupt uploaded documents if any, and (c) Non legible uploaded documents if any for evaluation of technical bid/pre-qualification for opening of commercial bid. Please note that pre-qualifying documents issued by the concerned appropriate competent authority on or before last ending day of on-line submission of technical bid documents and Commercial bid i.e. upto due date will be considered for technical bid purpose. The documents of technical bid issued by competent authority after last ending day will not be considered. Commercial bid will be opened on same day or thereafter, after the evaluation of technical bid."
- Bidders have to submit an undertaking in the attached proforma ANNEXURE-G declaring that their Firm is not Debarred/Blacklisted by Government/Semi-Government/Other Power Utilities, anywhere. - ii) The term "Bidder from a country which shares a land border with India" means: a) An entity incorporated, established or registered in such a country; or b) A subsidiary of an entity incorporated, established or registered in such a country; or c) An entity substantially controlled through entities incorporated, established or registered in such a country; or d) An entity whose beneficial owner is situated in such a country; or e) An Indian (or other) agent of such an entity; or f) A natural person who is a citizen of such a country; or g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- iii) The registration of the bidder from Competent Authority should be valid at the time of submission of bids and at the time of acceptance of bids. If the bidder was validly registered at the time of acceptance / placement of order, registration shall not be a relevant consideration during contract execution.

- vii) Offer received without the prescribed undertaking (as per Sr. No. iv, v, vi above as applicable) shall be liable for rejection.
