
Terms and Conditions :

4. E-enquiry should be duly filled in all respects and signed & sealed, failing which it will be liable for rejection.
5. In case of any dispute, decision of the Executive Engineer (C) MSETCL, EHV CCCM Division, Sangli shall be final and binding on the contractor.
6. Rates quoted shall be inclusive of all the Taxes.
7. Validity of rate shall be applicable for 60 days from the date of opening of E-enquiries.
8. Income Tax, as per prevailing rates will be recovered from your bill.

9. You have to quote your offers considering prevailing rates of GST. If the contractor is registered in GST, it is contractor's responsibility to pay the GST to appropriate Government authority. In case of GST unregistered contractor, should submit on his letter head an undertaking mentioning that "GST unregistered person".


