- 2. The period for providing of above material is 15 (Fifteen days) from the date of issue of work order.
- 3. Quantities mentioned in Schedule 'B' are approximate and payment will be made on actual quantities executed.
- 4. Payment will be made through R. A. bills as per directives of Engineer in Charge.
- 5. Rates quoted should be inclusive of all incidental charges like TDS & GST, Transportation and installation etc if any.
- 6. Rates quoted shall be inclusive of all T & P labour etc.
- 7. Work is to be carried out strictly as per the standard specification and as directed by the Engineer in Charge.

- 8. If any damages occur to the Company's property during execution, contractor shall make it good at his own cost & risk.
- 9. You have to quote your offers considering rate of GST. If the contractor is registered in GST, it is contractor's responsibility to pay the GST to appropriate Government authority.
- 10. Guarantee certificate as per manufacture's terms and conditions shall be submitted.
- 11. Right to reject any or all quotations without assigning any reasons is reserved.
- 12. Contractors are requested to visit/inspect the site before submitting their quotations.
- 13. The Vertical Deep Freezer (Chiller) shall be of Branded Make of **Blue Star**, **Voltas**, **Celfrost** only and the agency has to carry out servicing and maintenance of said Vertical Deep Vertical Deep Freezer (Chiller)
