TERMS AND CONDITIONS:

- **1.**The quotation must be submitted in sealed envelope duly super scribed with all details as Mentioned below:

- 2. Per day rates quoted should include provision of driver/operator his salary & allowances. Crane / excavator maintenance, repairs & other Govt. and Non Govt. charges on account of crane / excavator, oil (Lubricant), taxes and all other charges etc. including GST Tax. No extra charges will be paid. The rates are accepted on firm quotation basis.
- 3. Your quotation should reach this office on or before date: **06.06.2023** by 16:00 Hrs and the same shall be opened at 17.30 Hrs. on the same day, if possible.
- 4. The order is limited to the period of one year from the date of engagement of the crane / excavator or up to the exhaust of work order amount whichever is earlier.
- 5. The rates are valid for one year from date of engaging of crane / excavator.
- 6. Separate crane / excavator diary will be maintained by you as prescribed by the undersigned for the account of usage.
- 7. The work contract tax if applicable will be deducted from your bill as per rule.

- 8. According to the financial Act income tax will be deducted from your Bill at the rate of rule applicable of the contract value and certificate to that effect will be issued to you.
- 9. The MSETCL will not be responsible for any kind of accident or damages to the crane / excavator of driver /operator during the hired period.
- 10. All the financial liabilities arising out of accident shall be borne by the owner of crane / excavator as per the prevailing "Workman's Compensation Act".
- 11. In case of failure/maintenance of crane / excavator you will have to provide another crane / excavator on same terms & conditions and rate. If Duration of this type of failure/maintenance exceeds 10 days then the contract may terminated with the forfeiting of S.D. If you fail to make such arrangement, department shall make the arrangement at your risk & cost.
- 12. Any kind of crane / excavator breakdown should be attended by owner of crane / excavator. No charges will be paid by MSETCL during breakdown. Agency will have to provide alternate crane / excavator during breakdown.
- 13. Normally the service of the crane / excavator will not be used on Sunday and holidays. But if required you have to make crane / excavator available on Sunday and holidays. The payment will be made for day on which crane / excavator is used. No payment will be made for the days when the crane / excavator is not required for MSETCL during the period of hire.
- 14. Agency has to submit the undertaking regarding readiness to provide Crane and Excavator (JCB JS 80) as and when required along with Xerox copy all valid documents which are required. Also bidder has to submit the following documents of firm:
 - a. Shop Act / Grampanchayat NOC
 - b. Electrical Contractor license
 - c. PAN Card
 - d. GST Registration certificate

The quotations without the above mentioned documents are like to be rejected.

- 15. Driver should be managed by crane / excavator owner. He should have valid license to drive / operate such type of crane / excavator. The driver / operator should be polite in behavior and should not be drunker / smoker. The driver has to submit medical fitness certificate and has to maintain the crane / excavator dairy daily. Any misbehavior of driver reported by MSETCL's staff will be views seriously & you should provide alternate driver under such circumstances.
- 16. In case of difference of opinion, about interpretation of terms & conditions between Owner /Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency.
- 17. Any dispute/differences arise will be subjected to jurisdiction of Hon. Ahmednagar court only.
- 18. Bidder should not submit "Conditional Quotation" Such conditional offer shall be liable for rejection.
- 19. The owner/agency will be responsible for all risks that may arise during hiring period & crane / excavator operation.
- 20. All the rules regarding registrations of crane / excavator, sales tax, GST Tax & other Govt taxes etc should be borne by crane / excavator owner.
- 21. The insurance of the crane / excavator should be arranged by agency. The same should be valid during contract period.
- 22. The crane / excavator of owner if wants any clarification regarding any terms of condition, he should approach in writing to undersigned before quoting rates.
- 23. After due date no clarification will be given and the decision of undersigned will be final and binding to all the crane / excavator owners quoting for said work.
- 24. Stamp Agreement: The agency have to executed an agreement as per provision of "Mumbai Mudarank Adhiniam 1958 CL.34" with requisite stamp duty before placing order of hiring of vehicle. The stamp fees of Rs.500.00 will be borne by Agency. The necessary stamp duty for the agreement shall be borne by the contractor.
- 25. The work shall be supervised by concern Engineer Incharge, appointed by undersigned and it should be carried out to the satisfaction of Engineer in charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 26. The agency has to prepare monthly Bill in triplicate as per completion of work. Monthly Bill payment will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in SES by Concern Engineer Incharge. Payment will be made only for the days of actual hiring of Crane / excavator for Company's use only.

- 27. M.S.E.T.Co.Ltd. reserves rights to add or delete terms during the contract period if found necessary.
- 28. Undersigned reserve the right to reject any or all the quotations without assigning any reason thereof.
- 29. All payments such as penalty of RTO should be borne by you.
- 30. The entire document related with crane / excavator should be on the name of contractor.
- 31. The contract can be terminated by the authority at any time, without assigning any reason therefore.
- 32. If it is found that crane / excavator is not giving satisfactory service. The contract is liable for cancellation after giving 10 days notice with the forfeiting of S.D.
- 33. **Security deposits**: You have to pay security deposit of 5% of the proposed value of work order, which should be paid by you within ten days from the date of receipt of LOI order, either in Cheque/Demand Draft/Cash/B.G./FDR by nationalized or scheduled bank in the name of the Executive Engineer, 400kV R.S. (O&M) Division, Babhaleshwar. The same will be refunded after one month from the date of completion of work satisfactorily. You have to apply to concern Division Incharge for obtaining NOC, after receipt of NOC S.D. will be refunded as per availability of funds.
- 34. The validity of your offer should be for One year.
- 35. The taxes like GST will be applicable as per privilege rates & rules circular issued by Govt. time to time.
