- 4. **DISCARDED OFFER CONDITIONS:-**The Company reserves to itself the right to reject any or all offers which does not confirm to any of the conditions.
- 5. **PRICE:-**The rates quoted should be firm & price variation will not be applicable at any cost & conditional bid not accepted. The price should be quoted in order to supply of material at 400KV R.S. Karad.
