- 2. Rates quoted should be on firm quotation basis and No extra charges for transportation, T&P, skilled workmen etc. will be given and same will be arranged by you.
- <u>SCOPE OF WORKS</u>: Bi-Annual Maintenance Contract for the work of repairing & Servicing of 250 KVA Diesel Generator Set (DG Set) installed at under 400 kV RS Division Deepnagar-BSL-II..
- 4. <u>QUOTED RATES</u>:-You are requested to quote your unit rates for the items mentioned in the schedule 'A'. <u>(Please quote ex-works price in ex-works field & applicable GST in GST field).</u>
- 5. **<u>PAYMENT</u>**: Payment will be effected after completion of work, SAP Activities, as per actualwork done and as per availability of funds.
- 6. <u>RATES & TAXES:</u> The Rates quoted should be valid at least for 180 Days and should be including of all Labour charges & incidental charges including labour cess but excluding GST asper applicable rate & relevant act. Please quote your GST registration No. on quotation.

- 7. **WORK ORDER VALIDITY**: The work order is valid for 24 month or up to the exhaust of work order amount whichever is earlier.
- 8. The income tax & other taxes will be deducted from your bill as per prevailing rules.
- 9. <u>COMPREHENSIVE INSURANCE</u>: You have to submit the comprehensive insurance of United India Insurance Company Limited Policy of 60:40 ratio for work order amount as may be necessary to protect your (contractor) interests & the interest of The MSETCL, against all risk valid up to the work order completion period. - 10. **INCOME TAX:** Income tax. GST TDS will be deducted as per Govt. Rules.
- 11. <u>SECURITY DEPOSIT:</u> 5% of the order value as security deposit will have to be paid by you within 7 days from the date of issue of LOI order in the form DD/FDR/BG/Cash of any Nationalized / scheduled Bank in the name of the Executive Engineer 400KV RS Division Deepnagar-BSL-II. to this office valid for three years. The same will be refunded only after satisfactory completion of guarantee period.
- 12. In any loss occurs to MSETCL's property during execution of work, the same will be recovered as per prevailing rates from your bill.
- 13. <u>AGREEMENT:</u> The contractor has to execute the bond agreement as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with Rs.500/- stamp duty before starting of the work.
- 14. MSETCL will not be responsible for any accident or damages to your staff during execution of work. All safety precautions are need to be taken while working in switchyard and it is a responsibility of agency.
- 15. All other standard conditions of contract prevailing in MSETCL are applicable in this casealso.
- 16. <u>TOOLS & PLANTS</u>: -All tools & machinery required will have to be arranged by you at your cost. If the tools & plants are provided by MSETCL on rent basis, the standard rent as per MSETCLrules shall be recovered from your bills.
- 17. **<u>TERMINATION OF CONTRACT</u>**: The undersigned reserves the right to cancel the contract agreement, after giving due notice to the contractor, in the event of the breach of contract in any respect or undue delay in execution of work / starting of the work etc.
- 18. **<u>GENERAL:</u>** MSETCL general Terms and Conditions for works are applicable to this contract.
- 19. The undersigned reserves the rights to accept or reject any or all the Quotations without assigning any reason thereof.
- 20. The disputes, if any, shall be subject to the jurisdiction of the Bhusawal Court only.
- **21.** The undersigned reserves the right to cancel the SRM E-Enquiry at any stage or cancel any or allquotations without assigning any reason thereof.
- 22. <u>SUBMISSION OF BILL & PAYMENT:-</u> You will have to submit the original R. A. bill wise Tax invoice in triplicate including work order No., Pan No., GST No. to this office in the name of undersigned to this office. The same will be submitted to the concerned unit for further process. After that the concern Incharge will verify & certify the bill as per MSETCL standard procedure & submit the same to this office for effecting payment. After due audit & verification, the Executive Engineer, 400 kV RS Dn Deepnagar-BSL-II., shall make necessary arrangement for effecting of the payment as per the availability of funds at 400 kV RS Deepnagar-BSL-II.. However, the payment will be made as per actual measurement & as per the actual work done.

- 25) <u>DAMAGE TO PERSONS AND PROPERTY: -</u> You will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill.

26) SUBLETTING OF THE CONTRACT:-

a. The contract/work order of any part there of shall not be assign/transfer or sublet without prior written permission of undersigned. Even if competent authority such permission is granted it shall be responsibility of principal contractor to whom the work order was originally issued to compete the work as per terms of contract/work order.

- 27) <u>RISK AND COST:-</u>If you fail to carry out the work in full OR in part, the work will be got carried out from other party even at higher rates and the difference in rate will be recovered from your risk and cost. It will be treated as breach of contract & contract will be terminated and order will be cancelled by forfeiting the security deposit.
- 28) <u>SATISFACTORY PERFORMANCE</u>: If you fail to execute the work satisfactory as per time schedule, it will be treated as breach of contract & contract will be terminated and order will be cancelled be forfeiting Security Deposit.
- **29) T.D.S., GST, LABOUR CESS & APPLICABLE TAXES:-** The T.D.S. at source as per prevailing rates & rules or at the rate amended from time to time in accordance with the provision of financial act, GST as per Govt. - 32) <u>JURISDICTION: -</u> All disputes or difference arising under, out of or in connection with this order, so concluded shall be subject to the exclusive jurisdiction of Bhusawal Court. In case any damage occurs during the work, the cost of such damage will be claimed with Govt. Insurance fund, Mumbai; however if our claim is rejected then you will have to make the loss good at your cost. All the MSETCL rules and regulation provisions of Indian Electricity Acts and rules; other Govt. rules as may be applicable from time to time will be applicable to this order and the same will be binding on you.
- **33**) **<u>FIRST AID BOX</u>:-** You will have to keep & maintain the first aid box & safety measures at site for the labors.
