- 2) The GST registration Certificate if registered, PAN xerox copy must be enclosed with quotation.
- 3) If registered under SSI, the Photo copy of the registration should be attached with the quotation.
- 4) Material shall be warranted for minimum 1 year.
- 5) Material shall be provided as per Schedule 'A'
- 6) Material should be delivered within 15 days from the date of the issue of order at MSETCL Executive Engineer, PAC Division, Bapat Camp, Kolhapur. Three days will be reckoned for transit. The condition for delivery should be mentioned specifically otherwise, it will be presumed that you will supply the material within stipulated time.
- 7) The rates quoted shall be on firm quotation basis.
- The envelope should be super scribed as "QUOTATION FOR SUPPLY OF 1 NO DIGITAL CLAMP ON METER (TONG TESTER) & 1 NO DIGITAL MULTIMETER".
