Sealed quotations are invited from authorized contractors/bidders who are registered vendors for following work at SLDC, Airoli on or before 27.07.2023 up to 15:00 Hrs. with following terms and conditions.

Please quote your lowest rates for following works subject to terms and conditions stipulated below:

Terms & Conditions: -----→

- 1.) **Validity of the offer:** The offer shall be valid for 60 days from the date of opening the quotation.
- 2.) Payment: The invoice in duplicate along with delivery challan of the same may be submitted to this office. 100% payment will be released after completetion of the work in satisfactory condition. Work completetion report duly sighed by maintenance engineer in charge. No Advance payment will be made.
- 3.) **Period:** Work shall be completed within 120 days from the date of issue of this order.
- 4.) Work should be carried out as per the Indian standard & practice & to the satisfaction of the site Engineer in-charge.
- 5.) Security Deposit: You will have to pay security deposit amounting 5% of the value of order within 7 days of receiving work order & the same will be refunded to you 6 months after satisfactory execution of the order. In the event of unsatisfactory performance of the contract, or non-compliance to T&C this amount will be forfeited.
- 6.) **Safety:** The work should be carried out as per standard & established engineering practices and taking all necessary precautions, safety measures as per practice as per safety rules.
- 7.) Whenever there is paucity of funds, the priority of payments of bill of various agencies will be decided by the undersigned and all the rights in this regard are

reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest/compensation due to delay in their payments of bills on account of paucity of funds.

- 8.) **Penalty:** If the contractor fails to complete the work as per order in stipulated time period penalty towards delay @ ½ % per week maximum to the extent of 10% of order value will be levied and deducted from bill for non execution of the work.
- 9.) If any accident occurs to the contractor's labour, while on duty, department will not be responsible in any way either legal or financial for the accident to the contractor's labour and the same shall be at the risk and cost of the contractor. The contractor will have to pay the compensation as per workman's compensation Act to the labors.
- 10.) Warrantee of works :- The works executed against the order shall be covered under warranty for a period of minimum one years from the date of completion of works.
- 11.) No extra charges for transportation, T&P and Labour, material etc will be paid, it will be arranged by you only.
- 12.) **Guarantee:** After the competition of work the contractor have to maintain the work done in good condition for one year at your cost.
- 13.) Contractor will have to make good damages, if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 14.) The quantities mentioned in the attached Annexure 'A' are approximate and may vary during the course of execution. Bidder should quote the rates as per
  - Annexure- A . Contractor will have no claim for the alteration. However, payment will be affected as per the actual measurements, measured at site as per M.S.E.T.C.L.'s rules.
- 15.) Contractor will be responsible for accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing Workman's Compensation Act.
- 16.) You will have to submit following documents along with the quotation. A) PAN Number, B) Registration Certificate of Maharashtra shop&Establishment act 2018, if applicable, C) GST registration certificate if applicable, D) Similar type of work and its completion certificate. Copy of single order completed in any one of previous seven years for similar type of work/Supply of ACP paneling work and Glass cladding work amounting at least Rs.1,06,318/-.
- 17.) Vendor must be specialist in above said work. The work order only placed by authority not below the rank of Executive Engineer from any Govt./Semi govt./PSU/reputed private company will be considered. In case of failure to do so, quotation shall be liable for rejection.-

19) **Experience :-** Completion of work order for the same type i.e. ACP paneling work and Glass cladding work related woks carried out should be submitted with sealed quotation.

20) **Payment:-** The full payment after deduction of applicable statutory levies will be made by this office within 30 days of receipt of bill, by crossed account payee cheque for which the contractor shall send bills in triplicate giving the reference number of the work order.

21) **Claims:-** If the works carried out is not found satisfactory and to the required specification. SLDC shall have right to totally reject the work. The contractor shall be responsible for rearranging the execution of works to the satisfaction of Engineer in charge, at his cost.

22) The other levies Income Tax & WCT will be deducted as per MSETCL rules. Contractor shall have to pay service tax to the concerned authority as per prevailing rules. The bidder must visit the site location to survey the site for the work that is to be carried out.
