# **TERMS AND CONDITIONS:**

- 1) The work should be carried out as per PWD specification and instructions of the Engineer in-Charge and to the satisfaction of the undersigned.
- 2) The quantities mentioned in the attached schedule are approximate and likely to vary However, payment will be made as per the work actually executed and measured. The rates shown in enclosed schedule B are exclusive of GST.

- 3) The work should be completed within (12) MONTHS from the date handing over the site, failing which the contractor shall be liable to pay as compensation an amount equal to one percent or such similar amount as the competent authority may decide of the W.O cost for every day the work remain unfinished after due date of completion subject to the maximum 10% of the cost of the order.
- 4) The work which is of bad workmanship quality will not be measured and paid.
- 5) Other material such as require tools and plant will have to arrange by the contractor at hisown cost.
- The contractor will have to make good the damages if any made by him during the execution of work at his own cost.
- 7) The material should be got approved prior to fixing from the Engineer-in-charge.

- 12) You will have to deposit Rs.30,000/- (5% of Quotation value) as security deposit in cash/DD/FDR of any nationalized Bank within 3 days from the date of receipt or receipt of work order, failing which EMD will stand forfeited.
