- 3) **To submit bar chart within 10 days** from the date of receipt of LOA, indicating all activities for completion of the project.
- 3) Submit price schedule with **detailed breakup of unit rate into ex-works price and GST rates within 10 days from receipt of LoA.**
- 4) To complete the formalities like furnishing of Performance Bank Guarantee as per Clause No. 8.0 of Section-II of Book-I in prescribed format within 30 days from the date of receipt of LOA so that the contract agreement can be finalized early.
