The Sealed & Super scribed quotations are invited from supplier/vendors for Supply of Safety Shoes and Rain suits of various sizes for the employees working under EHV Projects Division, Aurangabad for the Block year 2017-20.

Terms and Conditions:-

- 1) **Due date:** The quotations complete in all respects, duly sealed & super scribed shall be submitted to this office on or before **30.05.2018** positively.
- 2) **Scope:** As detailed in **Schedule 'A&B'**
- 3) **Quoted rates:** The quoted rates should consider the cost of items strictly as per specification & test certificates etc. Taxes & Charges shall be mentioned clearly. If not mentioned, rates quoted will be considered as inclusive of all taxes & charges. While submitting the quotation the Schedule "A & B" should be filled in and signed.
- 4) The material offered should be strictly as per specifications given in Schedule 'A & B' and strictly in accordance with the approved samples. The sample should be got approved from the committee for procurement of

Safety Shoes and Rain Suits before delivery. All rights to approve the sample are reserved with procurement committee.

- 5) **Guarantee Period:** The material supplied shall be guaranteed for a period of 01 year from the date of supply at the storage against the defective manufacturing or workmanship. If supplied material found to be faulty within guarantee period, same should be replaced free of cost by the supplier.
- 6) The supplier will have to submit 01 No. of Sample for approval of competent committee in respect of the submitted quotation on following address on or before **03.06.2018** Office of the Executive Engineer, EHV Projects Division, MSETCL, Aurangabad. Administrative Building, Wing No.104 1st Floor, 132KV Harsool S/s Campus, in front of Central Jail Aurangabad 431008
- 7) In the event of failure of Supply, the ordered materials will be purchased by MSETCL from the open market at the Risk & Cost of the supplier in addition to forfeiture of S.D.
- 8) **Delivery period:** The material shall be supplied within 15 days from the date of the receipt of the work order to EHV Projects Division, MSETCL, and Aurangabad.
- 9) **Penalty for Delay:** If you fails to supply the materials within stipulated time Period, a penalty will be levied at the rate of ½ % per week on the delayed Portion of the material supplied per week delay, subject to the maximum of 10 % of the total value of the order.
- 10) Quotations will be disqualified in case of disclosing untrue and /or false information, or withholding information or part of information.
- 11) **Payment:** After completion of work successfully, the Bill in triplicate shall be submitted to the office of the Executive Engineer, EHV Projects Division, MSETCL, and Aurangabad. After recording of measurements by concerned engineer in-charge, the bill will be certified by Competent Authority. The payment will be made within a reasonable time by Division office as per availability of funds.
- 12) **Security Deposit:** The successful bidder will have to pay an amount equivalent to 5 % of contract value towards Security Deposit by Cash or D.D drawn in favour of Executive Engineer, EHV Projects Division, and Aurangabad . The Bank Guarantee of any nationalized Bank will be accepted against Security. The S.D. will be returned after 01 year from date of successful completion of supply as per order.
- 13) **Validity of offer:** The offer should be valid for our acceptance for a period of **60 days** from the Due date of same.

14) Documents required: The rate offer must be accompanied with following documents duly attested & signed by vendor.

- i) Information regarding full name and address of the company/ firm.
- ii) An authorization letter from the manufacturer regarding dealership
- iii) Registration Certificate of the firm as per Bombay Shop Act.
- iv) GST registration certificate
- v) PAN card.
- vi) Make (brand name) & the detail guaranteed features of specifications along with illustrated printed catalogue of the offer.
- vii) Order copies/Experience Certificate for similar type of works preferably in MSETCL or Government/Semi-Government/Private organizations. Order copies/Experience Certificate issued by authority not below the rank of Executive Engineer in case of Government/Semi-Government organizations will be required to be submitted.

15) The undersigned reserves the rights for cancellation of any or all quotations without assigning any reason.

16) In case of any dispute for this contract, the jurisdiction of court will be Aurangabad.

17) Not contained herein all other terms and conditions of MSETCL will be applicable to this enquiry.

- 1. The shoes Sole contain “ISI mark “embossing compulsory.**
2. The shoes should meet the characteristics as per the IS 15298 & required the Test report of IS 15298 from central/State Government approved laboratory showing following characteristics of materials/safety shoes;
 - i) Design include Thickness, Barton leather
 - ii) Shoes Sole:-PU Single cavity direct injected sole, ISI mark, Chemical & Oil Resistances, Good wear & Tear Resistances
 - iii) Toe Protection Test
 - iv) Tensile strength & elongation of leather
 - iv) Corrosion resistance& compression resistance
 - vi) Electrical properties include Megger & HV test (15kV level & above)
 - Viii) Length of shoe laces is 1 meter.
3. The shoes also meet the standard specification & norms of MSETCL.
