The Clause No. 4.2 of General Technical Requirement of Technical Specification (Annexure D) and accordingly Sr. Nos. 18, 19 & 21 of General Technical Particular (Annexure A) are hereby amended as under:

Further, the equipment should have integrated high resolution viewfinder (minimum 640 X 480 Pixels on both) for the ease of operator. Non fulfillment of this requirement during demonstration will be considered as ground for rejection.	The Equipment shall be provided with minimum 4" LCD Screen (Touch screen or Hybrid).
