The Clause no. 8 of Section-III in r/o subject tender is amended as follows:

In the event of non-submission of bid/ offer during the matching process by the L-1 bidder, the offer earlier submitted by the firm against the tender will be summarily rejected.</p> <p>The eligibility for C-1 Matching shall be as stated in Clause No. 19 of Section I of the Tender document.</p> <p>b) In addition to the quantity allocation, criteria mentioned in clause no. 19.0 of Section-I of tender specification, the following criteria will be applicable:  “ The maximum quantity which will be allotted to any bidder will be such that the cumulative total of order placed against this tender and supplies due from the bidder against order placed by CPA for procurement of high cost/small quantity items viz.
