The Maharashtra State Electricity Transmission Company Ltd., Mumbai, has invited offers in TWO bid system (Techno- commercial and price bid) from the eligible bidders for the SRM e-Tender No. T-1902 for Supply & laying of UG cable for 220kV DCMC Uran-Kharghar line – 09 Kms route length (with one spare cable length) along with dismantling of existing 220kV DCDC Uran - Kharghar O.H. line under Vashi Zone-2nd call (Rfx. no. 6000000691).

The following changes are incorporated in the tender details as below:

2.1.1 (a) Technical Experience	The bidder should be a manufacturer having manufacturing facility in India and experience of supply and laying, jointing, terminations & commissioning of cable as mentioned in clause No. 2.1.2 & 2.1.3 below respectively	The bidder should be EHV cable manufacturer & having experience of supply and laying, jointing, terminations & commissioning of cable as mentioned in clause No. 2.1.2 & 2.1.3 below respectively.
2.1.1 (c)	The EPC agency not meeting criteria i.e. who is not a manufacturer of cable or accessories can also participate as a sole Bidder with the undertaking from cable & accessories manufacturer, who meets the criteria as mentioned at 2.1.2 below. The bidder should also have the experience of Supply, laying, jointing, termination & commissioning of aggregate length of 10 Ckt Kms (3 Ph Ckt Kms) of 220 kV and above EHV Cable of size as mentioned in the scope of tender or above with accessories & the same should be in satisfactory operation for period of 2 years as on the date of bid opening.	The EPC agency who has registered in India and not meeting criteria i.e. who is not a manufacturer of cable or accessories can also participate as a sole Bidder with the undertaking from cable manufacturer, who meets the criteria as mentioned at 2.1.2 below. The bidder should also have the experience of Supply, laying, jointing, termination & commissioning of aggregate length of 10 Ckt Kms (3 Ph Ckt Kms) of 220 kV and above EHV Cable of size as mentioned in the scope of tender or above with accessories & the same should be in satisfactory operation for period of 2 years as on the date of bid opening. Note: 1) Indian cable manufacturer can participate in the tender in any form, i.e. sole bidder or through MAF, provided that should not have more than two bids in single tender. 2) Foreign cable manufacturer can give one MAF to Indian EPC bidder.
