The Routine/Acceptance Tests shall be conducted at Manufacturer's Works. The Manufacturer's Testing Lab shall have NABL Accreditation. All the Equipment used for Testing should have valid Calibration on the date of Testing.

Manufacture shall have In-House Routine Test Facilities (As per IS 16227 and IEC: 61869) and Test Facility for Temperature Rise Test, Lightning Impulse Test and Composite Error Test by Direct Method (for Ensuring Low Reluctance of PS Core).

The Manufacture shall carryout Lighting Impulse Test & Temperature Rise Tests on One random selected CT/PT of each Lot of 25 Nos. of every Item. In case, the Lot size is less than 25 Nos., then also it shall be mandatory to conduct aforesaid Test on One sample from such Lot.

In case the Manufacture does not have In-House Facility for carrying out Lightening Impulse Test then same can be carried out at other Facility (i.e NABL Accredited Lab), in presence of MSETCL's Representative.

All expenditure for carrying out Lightening Impulse Test outside the Manufacturer's Work shall be borne by the Bidder including Charges (Inclusive of TA & DA) towards Deputation of MSETCL's Representative. In case the CT/ PT does not pass the Test successfully, the entire Lot will be rejected.

The Delivery Schedule i.e. Commencement and Completion of Item awarded to you is indicated in Column No. 6 of above Table.
