PRICE VARIATION CLAUSE FOR POWER TRANSFORMERS AND REACTORS COMPLETE WITH ALL ACCESSORIES AND COMPONENTS OF VOLTAGE ABOVE 33 KV AND UP TO 400kV SUPPLIED AGAINST DOMESTIC CONTRACTS

This price variation clause is applicable for Transformers and Reactors of voltage above 33 kV and up to 400 KV supplied against domestic contracts. A separate price variation clause IEEMA/PVC/PWR TRF_Up to 400 KV/DE/2021 has been evolved for above types of Transformers and Reactors supplied against export/deemed export contracts.

The price quoted/confirmed is based on the input cost of raw materials/components and labour cost as on the date of quotation and the same is deemed to be related to prices of raw materials and all India average consumer price index number for industrial workers as specified in the price variation clause given below. In case of any variation in these prices and index numbers, the price payable shall be subject to adjustment, up or down in accordance with the following formula:

- a) For computation of PV the 'date of opening' referred above / in IEEMA PV Circular shall be the 'published' date (including extension, if any) of opening of Techno-Commercial bid of the tender till which time the bidder had the option to modify his quoted price and not the 'actual' date on which the Techno-Commercial bid of the tender is opened.
- ii) The Price Variation shall be calculated as per IEEMA PV Formula and monthly indices published by IEEMA.
- iii) For supplies effected / works completed within the contractual period, the Price Variation will be payable as per above clauses.
- iv) In case of contract / Order completed / executed beyond the contractual period, the Price Variation will be payable for the supplies effected / works completed within the contractual period. For balance supplies effected / works completed after the contractual period, Price Variation will be payable as per above clauses, only for the extended time period approved by the Competent Authority.

Note-

- a) The MSETCL shall not be liable for any additional cost incurred by the Contractor on account of price variation for supplies effected / completion of works beyond the original contract period, on account of default by Contractor. However, in such case, if PV calculated for this period is negative then same will be deducted / recoverable from agency.
- b) PV shall be payable beyond the original contract period, if time extension is granted as per provisions of GTC Clause due to force majeure conditions or due to delay/defaults on account of MSETCL, subject to the conditions that same has been considered by competent authority based on the documentary evidence furnished for granting Time Limit Extension with PV and subsequently a Time Limit Extension Letter is issued with PV by MSETCL.
- c) The 'date of delivery' shall be the date on which the equipment / material is notified as being ready for inspection / dispatch or the contracted delivery date whichever is earlier whenever supplies are effected within contractual delivery period. In case the supplies are effected after the contractual delivery period, the date of the delivery for Price Variation purpose would be one out of the two on which the price variation is less.

NOTE: All prices are exclusive of GST and exclusive of any other central, state or local taxes etc.

- a) The details of prices are as under:
 - 1. Price of 8 mm CC copper rod (in Rs/MT) is ex-works price as quoted by the primary producer.
 - 2. The price of CRGO is the price of CRGO Electrical Steel Lamination in Rs./MT suitable for Transformers of voltage above 33 kV and up to 400 kV
 - 3. Price of Steel is the average retail price of steel plates 10 mm thick as published by Joint Plant Committee (JPC) in Rs./MT
 - 4. The price of Insulting materials (in Rs./Kg) of pre-compressed pressboards of size 10 mm thick, 3200 mm x 4100 mm is the average C&F price in free currency per MT converted into Indian Rupees with applicable exchange rates prevailing as on 1st working day of the month as quoted by primary suppliers.
