1	Type Test	CL No. 7.1.1 Type Test	All the equipments offered shall be fully type tested in accredited test laboratory as per the relevant standards, amended up-to-date. Type tests conducted in India shall be from NABL (National Accreditation Board for testing and calibration Laboratories) accredited testing laboratories. These tests must not have been conducted earlier than ten years from the date of opening of bids except for the tests for which testing facility is not available in India. However, such tests (i.e. for which testing facility is not available in India) should have been carried out successfully as per IEC 62271 100 standards amended upto date. In case the type tests are conducted earlier than ten years, all the type tests except for the tests for which testing facility is not available in India, shall be carried out by the successful bidder in an accredited test laboratory in presence of purchaser's representative free of cost before commencement of supply. Bidder shall give the purchaser three weeks advance intimation to enable him to depute his representative for witnessing such Type Tests.	These tests must not have been conducted more than five years from the date of opening of bids.	Shall be as per Technical Specification.
